RFTAP/SBCQ/3.32 “Development of mechanism of stimulation of the RF subjects, in order to implement regional finance recovery programs and to enhance financial management quality”

The Russian Federation has received financing from the World Bank toward the cost of the Regional Fiscal Technical Assistance Project, and intends to apply part of the proceeds for consultant services under the contract RFTAP/ SBCQ/3.32 “Development of mechanism of stimulation of the RF subjects, in order to implement regional finance recovery programs and to enhance financial management quality”.

The services include: analysis of implementation practice of regional finance reform programs by the RF subjects in 2005-2009; development of conceptual proposals and draft normative legal acts, defining the mechanism of federal support to regional programs of finance recovery and enhancement of financial management quality, including procedure of allocation of subsidies to the RF subjects, in order to support implementation of the mentioned programs; implementation of test researches of the developed mechanism of support to regional finance recovery programs and enhancement of financial management quality in the RF subjects; development of supporting and presentation materials, necessary for holding of regional meetings by the RF Minfin, in order to introduce representatives of financial bodies of the RF subjects to the developed mechanism of support to regional finance recovery programs and enhancement of financial management quality.

The services are to be implemented from June 2010 to December 2010.
