**RFTAP/QCBS/2.10 «Modernization of mechanism of special economic zones as a form of PPP in order to implement budget policy of support to national economy's development based on international experience»**

The Russian Federation has received financing from the World Bank toward the cost of the Regional Fiscal Technical Assistance Project, and intends to apply part of the proceeds for consultant services under the contract RFTAP/QCBS/2.10 «Modernization of mechanism of special economic zones as a form of PPP in order to implement budget policy of support to national economy's development based on international experience».

The services include: analysis of the Russian experience in implementation of special economic zones projects, comparison with international experience in order to determine the directions of further development of normative regulation and practice of preparation and implementation of special economic zones projects; development of proposals on effectiveness increase for budget assets usage during implementation of special economic zones projects at the regional and local levels; development of proposals on improvement of normative legal and methodical base for special economic zones management and implementation; development of proposals on modernization of mechanisms of financing of activities on development of adjacent territory for the benefit of special economic zones functioning; development of proposals on improvement of management procedures over supportive tools of investment activities at the regional and local levels at the expense of the federal budget.

The services are to be implemented from June 2011 to December 2011.

The Non-commercial Foundation for Enterprise Restructuring and Financial Institutions Development hereby invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).
