**RFTAP/SBCQ/3.33 “Methodological assistance in developing analytical materials on financial backstop to expenditure obligations of constituents of the Russian Federation”**

The Russian Federation has received financing from the World Bank toward the cost of the Regional Fiscal Technical Assistance Project, and intends to apply part of the proceeds for consultant services under the contract RFTAP/ SBCQ/3.33 “Methodological assistance in developing analytical materials on financial backstop to expenditure obligations of constituents of the Russian Federation”.

The services include: development of methodological recommendations on establishing a system of analytical forms to include data on planned allocations in budgets of RF subjects and municipal entities; development of methodological recommendations on providing analytical forms on budget execution by RF subjects and municipal entities; development of methodological recommendations on filling in planned (reporting) forms on the network, staff and cohorts by recipients of budget funds financed from the budget of the RF subject and budgets of municipal entities; and development of guidelines for RF subjects on the automation of analytical processing of reporting data developed within the frame of the Project and procedures for preparation and submission of respective forms of specified reports.

The services are to be implemented from May 2011 to September 2011.

The Non-commercial Foundation for Enterprise Restructuring and Financial Institutions Development hereby invites eligible consultants to indicate their interest in providing the services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.).
